REGISTRATION FOR MCC SUMMER CAMPS:

Registration closes two weeks prior to the starting date or when a session is full. Camp staff members reserve the right to request age verification of campers. MCC reserves the right to cancel camps with insufficient enrollment. Full refunds will be granted for any camp cancelled by the college.

REFUND POLICY: Full refunds will be allowed until one week prior to the start date of the camp. Refunds requested within one week of the camp starting will have a \$10 fee withheld. No refunds will be granted after camp starts.
