General Description: Custodians will perform custodial functions 1 day per weekend & 3 consecutive evenings throughout the week.

Position Duties/Functions:

- 1. Maintain MCC standard of cleanliness:
 - i. Sweeping, mopping, waxing, scrubbing, general floor care, window cleaning, etc.
 - ii. Daily restroom cleaning
- 2. Make minor maintenance repairs as needed, in consultation with supervisor.
- 3. Assist in the set up and tear down of College events.
- 4. Ensure doors/buildings are secure when appropriate.
- 5. Help move heavy furniture and equipment.
- 6. Assist with care of grounds including weed whacking, lawn mowing, snow removal from sidewalks, etc.
- 7. Security of College property.
- 8. Performing above and other related duties with a degree of independent judgment and as assigned.

Required Qualifications:

- 1. Ability to use good judgment in performing custodial duties.
- 2. Ability to work independently and as part of a team.
- 3. Ability to lift up to 50 pounds.
- 4. Ability to communicate effectively.
- 5. Highly motivated and a self-starter.
- 6. High level of attention to detail.
- 7. Submit to a physical exam upon offer of employment.
- 8. Valid Michigan Driver's License is required.
- 9. High School Diploma required.
