**BE IT FINALLY RESOLVED**, That Connie L. Stewart be removed as an authorized signatory, effective November 11, 2025.

The Trustees reviewed the 2025 College Membership Report.

Connie Stewart and Theresa Rowland departed the meeting at 6:05 p.m.

The Trustees discussed their Board self-evaluation.

Trustee Bob Byram presented a key person insurance report and recommendation.

Upon motion duly made by Esther Combs and supported by Joyce Kitchenmaster, the following **MOTION** was unanimously approved: MCC shall purchase a key person term insurance policy to cover President Dr. Bradley J. Barrick in the amount of \$500,000 for a 20-year term.
